# 01 MAR10418 - Certificate I in Maritime Operations

(Coxswain Grade 2 Near Coastal)

The Certificate I in Maritime Operations (Coxswain Grade 2 Near Coastal) reflects the role of individuals who work as a Coxswain Grade 2 Near Coastal in the maritime industry and who command a commercial marine vessel up to 12 metres in length, with propulsion power that is unlimited for an outboard engine or up to 100kw for an in board engine that is not carrying passengers and that operate this vessel in sheltered waters or as a tender or auxiliary vesselwithin 3 nautical miles (*nm*) of a parent vessel within the exclusive economic zone (*EEZ*) or within 3nm from point of departure, shore base or aquaculture lease.

This level of qualification is currently cited as meeting some of the requirements for certification as a Coxswain Grade 2 Near Coastal as defined by the National Standard for Commercial Vessels (NSCV) Part D.

## 02 Course Overview

Certification will require achievement of the MAR10418 Certificate I in Maritime Operations (Coxswain Grade 2 Near Coastal), gualifying sea service and completed Australian Maritime Safety Authority (AMSA) approved task book or qualifying sea service, AMSA final assessment, an appropriate radio certificate of proficiency and an AMSA approved first aid certificate; people seeking certification should check with AMSA.

The following job title represents the role of those having achieved this qualification:

Coxswain Grade 2

### **03 Entry Requirements**

While there are no formal entry requirement you should be at least 16 years of age and ideally have a minimum of year 10 English and Mathematics.

There are however, requirements for candidates to have sound Language, Learning and Literacy (LLN) skills appropriate for this qualification on and basic technology skills as the bulk of the course work is provided online. To this end all applicants will be required to undertake an *LLN* assessment.

Please Note: Students wishing to enroll for this course must be aware that to gain an AMSA certification/license the following documents must be completed.

- 1. Eye sight test Certificate AMSA document 542 (Colour blindness)
- 2. Self-Declaration on Medical form AMSA document 558' and if necessary
- 3. Certificate of Medical Fitness for a Marine Qualification on AMSA document 559

## **06** Learning Support

All applicants for this qualification will be required to complete a language, literacy and numeracy *(LLN)* assessment prior to commencement of this program of study to determine their current skill levels against the skills required to complete the competencies.

A Paradigm Training Group administrative officer will take action if required.

Applicants who fall below the required skill levels for this qualification will be interviewed by an *LLN* qualified assessor to identify the level of support required with the view to the achievement of successful outcomes. A learning plan will be developed to identify opportunities for support and where practicable, to ensure the learner is able to actively participate in this program.



#### 07 Course Delivery, Assessment and Duration of Learning

Learners will be required to complete this qualification within 12 months of enrolment. From enrolment and completion of **PTG's** language literacy and numeracy **(LLN)** assessment, learners may access **PTG's** online learning system, for theory based learning and assessment and with Trainer and Assessor email support.

Workbooks will be made available for those who prefer to work with hardcopy documents. After the completion of the on-line theory component, classroom delivery will be provided over a 6 day period on the Gold Coast where further learning and review will take place and will include theory, practical scenarios and on-water activities.

Learners will also be offered the opportunity to book into a **PTG** 1 st aid course or refresher. Further, building on online theory and class based theory and practical activities, all learners will be provided with an **AMSA** task book. This task book must be used to log practice in real work conditions. On completion the learner must return the completed task book to an AMSA approved PTG assessor for review and sign off.

Assessment may be conducted through combinations of the following methods

- Online and written assessments
- Face-to-face practical assessment


### 08 Licence

The Coxswain Grade 2 Near Coastal Certificate of Competence is issued by Australian Maritime Safety Authority. In addition to this course and pre-requisites for the licence profile you will also need to obtain qualifying sea-time.

#### **09** Location

PTG Classrooms are located on the **Gold Coast**.

This course may also be held in other areas.





## 10 Recognition of Prior Learning

Recognition of Prior Learning (**RPL**) recognises your existing experience gained through life or work for which you may not have obtained a formal qualification.

Applicants who are able to supply valid, sufficient, current and authentic evidence of having the skills and knowledge required for any or all of the required units for this qualification, may be eligible for **RPL** and should consult with **PTG** for advice on this process.

## 11 Required Learner Resources

You will need a laptop or iPad to access course resources.

For classroom delivery and practical sessions, the following items are required:

- Students must wear appropriate clothing and enclosed footwear must be worn at all times while on training vessels.
- Swim wear and towel will be required for safety at sea units.

#### 12 Course Fees

#### Cost \$2, 495.00

\$1,500.00 will be payable upon enrolment and access to the student platform. The remaining \$995.00 will be payable before the 5 day practical session or once 50% of the course has been completed, whichever is first.
